UTAH PERMIT CONSTRUCTION ACTIVITY POSTS NEW RECORD VALUE

Permit-authorized construction activity in Utah during the months of April, May and June of 2004 was characterized by continued strength in residential building—both single-family homes and multifamily buildings—and a rebounding nonresidential sector. During the quarter, permits were issued for 5,130 new single-family homes, bringing the total for 2004 to 8,671, a 9.9 percent increase over the first half of 2003. The number of new single-family homes through June is second only to the same period in 1978. The number of new apartments and condominiums jumped 27.0 percent, as 3,005 new units received permits. For the year, permits have been issued for a total of 12,021 new dwelling units, an increase of 13.1 percent over 2003. Residential valuation surged to another record, reaching \$1.7 billion for the first six months of 2004, 23.0 percent above the previous six-month record posted in 2003.

Nonresidential construction value for the first half of the year totaled \$473.7 million, a 16.4 percent increase over the same period in 2003 and the best performance since before the 2002 Winter Olympics. Construction of new retail buildings bolstered the sector, along with office buildings, and new church buildings.

The additions, alterations and repairs sector registered a slight decline of 3.5 percent from 2003 levels, to \$236.6 million. Nonresidential additions, alterations and repairs declined 10.9 percent, to \$155.4 million, while residential additions, alterations and repairs rebounded from lower levels last year to reach \$81.2 million, up 14.7 percent.

Total permit-authorized construction value for the first half of 2004 reached \$2.4 billion, up 18.5 percent over the same period in 2003 due in large part to the strength of residential construction sector, and partly due to rising costs of materials (Table 1).

Residential Construction

Not since 1978 has Utah had so many permits issued for the building of single-family homes. During the first six months of 2004, 8,671 new single-family homes were authorized, the most since the record year of 1978 when 8,833 permits were issued during the same period. New single-family home permits issued during the second quarter totaled 5,130, a number 15.8 percent higher than last year. Each month during the quarter recorded gains over the same month in 2003 in single-family permits. Mortgage rates continue to boost the sector, with the rates remaining below the 6 percent level. More significant, perhaps is the increase in valuation in single-family homes, climbing from \$1.18 billion in 2003 to \$1.43 billion in 2004, up 21.3 percent. Substantial increases in

the costs of building materials have been reported by builders and others in the industry, although the price increases seemingly have not dampened the demand for new homes in Utah.

Multifamily building also surged ahead, as 3,005 new apartment and condominium units were authorized through June, 27.0 percent higher than in 2003. One-half (1,510) of these new units were condominiums and townhomes, which also receive a significant boost from low mortgage rates. The largest multifamily project for the quarter was a 209-unit apartment complex in Salt Lake City, valued at \$18.6 million. Another large apartment complex was begun in North Salt Lake, with 180 units and valued at \$8.2 million. It should be noted that permits for apartment projects frequently are all taken out at the same time, while condominiums mostly are built as the units are sold, much like single-family homes. (Table 2).

St. George led individual cities by far as the city issuing the most permits for the construction of single-family homes with 519 through June. Washington City, just north of St. George, authorized 380 new homes during

1970-2004

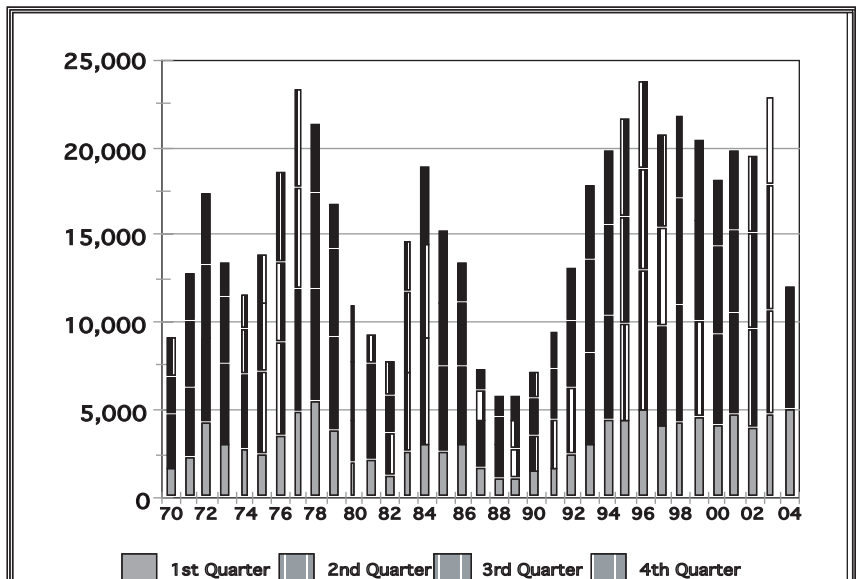

1976-2004

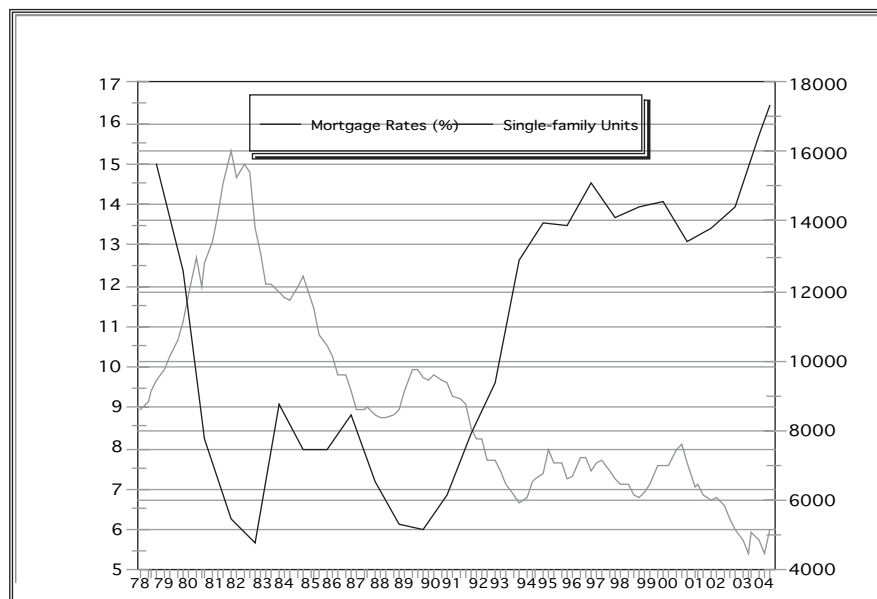

the period. Other top sites for single-family building were located in Salt Lake County: West Jordan, with 427 new single-family home permits, Herriman (419), South Jordan (359), and Draper (280). Lehi, in Utah

County, issued permits for 406 new houses. Nearly eight of ten new single-family homes receiving building permits through June were located in four counties: Salt Lake (2,375), Utah (1,745), Davis (1,346) and Washington (1,226). The same holds true for condominium and apartment units. Salt Lake (859), Utah (610), Washington (429), and Davis (378) account for three-quarters of new multifamily construction. Residential construction by county, type of unit and valuation is shown in Table 3.

It seems likely that the number of new single-family homes permitted in 2004 will approach record levels. While building may moderate toward the end of the year, total new dwelling units (single-family, multifamily and mobile homes) should be close to the 23,737 recorded in 1996. Even more certain is that residential valuation will, for the second year in a row, reach record levels. As long as mortgage rates remain relatively low, new condominium and townhomes may continue to provide nearly half of all new multifamily units.

Nonresidential Construction

Nonresidential construction activity continued to recover during the second quarter of 2004. Valuation of new nonresidential construction through June totaled \$473.7 million, up 16.4 percent from the same period in 2003. The two main impediments to higher levels of nonresidential construction—an oversupply of office, retail and warehouse space and lack of new business investment due to the national recession—have both eased. Nonresidential construction that is related to population growth and new housing has bolstered the sector as new retail stores, office buildings and churches led the rebound in the nonresidential sector.

A number of multimillion dollar projects received building permits during the months of April, May and June. The largest project receiving a permit was a new hospital building located in Research Park, at the University of Utah for \$19.0 million. A bank building (\$7.2 million) with an associated parking structure (\$4.0 million) in Provo and a new office building in suburban Salt Lake County, valued at \$6.8 million were additional large projects receiving permits during the

quarter. Notably, the number of projects with a valuation of between \$1 million and \$5 million expanded over the January-to-June period, adding to the rebound of the nonresidential construction sector. A list of nonresidential projects over \$1 million receiving permits during the quarter is shown in Table 4.

As illustrated in Table 5 and Figure 3, construction activity for major types of nonresidential buildings was

mixed. Retail building continued at levels above the five-year average for the sector, with \$98.3 million in valuation through the month of June. Building of churches more than doubled over 2003 at \$37.7 million. New office building construction also showed significant gains over last year. After four years of little activity, the hotel sector surged ahead with \$17.2 million in construction value. Sectors still lagging with below-average valuation include industrial and

(millions of dollars)

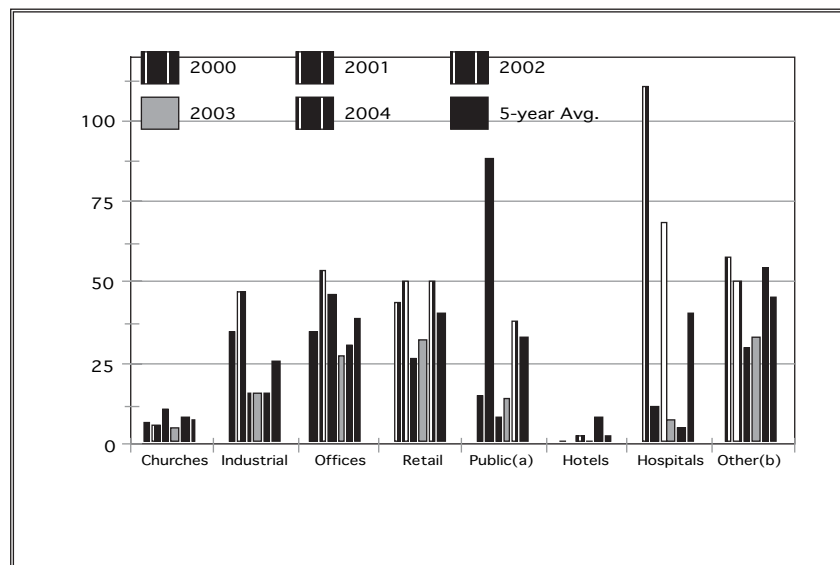

manufacturing buildings, down more than 50 percent from the sector five-year average and public buildings, which recorded \$47.5 million—less than the five-year average of \$54.5 million, but substantially better than 2003 levels.

Nonresidential construction may not reach the record levels seen just before the Winter Olympics, however several major projects will add significantly to the sector in the near future. Permits will be issued later this year for the first of several hospital buildings at the new Intermountain Medical Center campus in Murray. Also on the horizon are the announced redevelopment of the downtown malls and new educational facilities. Increased residential building in the suburbs will lead to more new churches, grocery stores, retail centers and health care facilities.

Additions, Alterations and Repairs

The additions, alterations and repairs sector declined 3.5 percent from the same period of 2003, from \$245.2 million to \$236.6 million. Nonresidential activity in this sector dropped 10.9 percent to \$155.4 million, while residential renovations increased 14.7 percent to \$81.2 million.

Just one significant project was begun during the second quarter. A bank building remodel in Salt Lake City, valued at \$5.8 million received a permit in April. Additions, alterations and repair projects receiving permits valued at more than \$1 million are shown in Table 6.

Non-Permit Construction

Many public buildings (federal, state, local, and schools) do not require city permits, and therefore do not appear in the permit-authorized building data. Also not included in permit-authorized data are infrastructure projects such as construction of roads and highways, light rail, commuter rail, pipelines and dams. Some school districts do require local building permits, consequently, a small number school projects are included in the permit-authorized construction data.

Bureau of the Census Statistics

To determine how construction activity in Utah compares with other Census regions and the nation, the Bureau of Economic and Business Research uses statistics compiled by the U.S. Bureau of the Census. Due to differences in surveying and modeling methodologies used by the Census, the statistics are not strictly comparable to those reported by the Bureau of Economic and Business Research. Information on nonresidential building by state is not collected by the Census.

According to Census data, residential construction showed strong growth nationwide during the first half of the year. The number of single-family units increased 14.1 percent, while multifamily units increased 6.7 percent, and total units increased by 12. percent. The value of residential construction activity rose 20.9 percent for the nation as a whole.

In the Mountain region, all but one state showed positive growth in the number of new residential dwelling units during the first half of the year. New authorized dwelling units declined by 16.2 percent in Montana due to a 9.2 percent decrease in the number of new single-family homes. Residential construction activity in Colorado reversed the losses of 2003, recording a gain of 24.1 percent.

States showing the strongest growth in new single-family homes were Nevada (40.1%), Arizona (26.2%), and Wyoming (23.9%). Permit-authorized multifamily units during the quarter rose 34.9 percent in Colorado, 25.4 percent in Arizona and 2.1 percent in Utah, according to Census data. All other Mountain states saw

declines in multifamily building: Idaho (-8.5%), Wyoming (-12.7%), Nevada (-20.7%), Montana (-26.7%) and New Mexico (-39.8%). Bureau of the Census data for states and regions are shown in Table 7.

Second Quarter 2004 Highlights and Outlook

- Single-family home building continued at near-record levels, with more new homes receiving permits each month during the quarter than for the same month in 2003. For the months of April, May and June, permits were issued for 5,130 new homes, compared to 4,429 permits in the second quarter of 2003, a gain of 15.8 percent. For the year, 8,671 permits have been issued for single-family homes, up 9.9 percent from year-ago levels. Single-family homebuilding will likely continue to be the main-stay of the Utah construction industry in 2004, as mortgage rates remain at low levels.
- Multifamily construction also increased substantially during the quarter with 1,629 new apartment and condominium units receiving permits, an increase of 31.5 percent over 2003. Multifamily units for the year are up 27.0 percent to a total of 3,005 apartment and condominium units. Half of all new multifamily units receiving permits for the first six months of 2004 have been condominiums and townhomes, reflecting the influence of still-low mortgage rates.
- Residential valuation again reached new heights in the first half of 2004, jumping 23.0 percent to a record \$1.7 billion. Valuation of new homes, condominiums and apartments will continue at a record pace through the remainder of 2004.
- Nonresidential construction activity recorded the highest value since 2001, bolstered by the improving state economy and still-strong retail building. Valuation of new nonresidential construction through June totaled \$473.7 million, up 16.4 percent from 2003. Nonresidential construction activity will continue to improve, especially with the expected growth in the health care sector.
- The additions, alterations and repairs sector was down 3.3 percent from year-ago levels, but is showing signs of improvement. The valuation of residential additions, alterations and repairs posted strong gains, rising 14.7 percent to \$81.2 million, while the nonresidential additions, alterations and repairs sector declined by 10.9 percent to \$155.4 million.
- Total permit-authorized construction value for the first half of 2004 reached \$2.4 billion, up an impressive 18.5 percent over the same period in 2003. Continued strength in the single-family home sector will combine with stronger nonresidential construction activity to raise permit construction values to record levels by the end of the year.

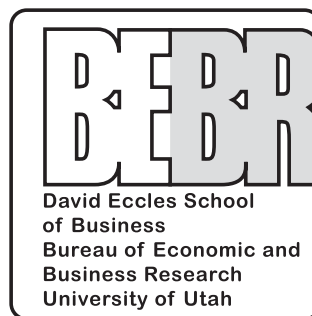
